- Delivers curricular lessons

- Conducts psychological and academic assessments
- Identifies student learning and behavioral disabilities
- Provides diagnostic information and recommendations for determining special education services for those identified in Chapters 14, 15, and 16 of the Pennsylvania Code, including Eligible Disability Categories

1 Full Time

- Provides crisis and emergency assistance to students and school
- Completes threat assessment / risk assessments of students
- Provide supportive case work to children and their families, including parent/caregiver education and self-advocacy.
- Conducts home visits to ensure student residency, attendance and support

Spring 2025 only. Ends in June.

Option for additional support next year.

- Referral based process from Core Team/ MTSS Team/ Child Study Team, or direct referral
- Parental permission needed for participation
- Evidence based counseling program
- Upon completion, referred back to school counselor
- If additional support is needed after completion of program, discussion through core team to additional services

Mental Health Counseling

Elementary - 2

- Provides direct 1:1 counseling in a student's IEP as a related service
- Special Education Students ONLY
- Progress monitoring on a student's goal, with titration plan in place
- Coordination with school counselor and IEP team

REACH

Staff:

Arcola - 2

Skyview - 1

Elementary - 1

- Extended mental health services and ongoing support
- Daily 1:1 counseling and group counseling
- Offers long-term treatment options tailored to the student's needs
- Works closely with student and family for continuous care and improvement
- Reports on student(s) progress to child study team

- Student's mental health needs exceeds building support
- Could be:
 - Schooling through Partial Hospitalization Program
 - Alternative School

Prevalence of Mental Health Needs

- **National Statistic:** 1 in 5 students in the U.S. experience a mental health disorder each year
- **Implication for Methacton:** This equates to approximately **917** students within our district.
- Currently we are servicing **402** students in some capacity with our mental health supports.

Early Onset of Mental Health Disorders

- **Statistic:** 50% of all lifetime cases of mental illness begin by age 14
- **Significance:** Early intervention is critical within our K-12 system.

Factors Contributing to Continued Need of Mental Health Supports:

- Suicidal ideology
- Depressive symptoms:
 - Depression
 - Food Insecurity
 - Sleeping less
- Exposure to explicit content earlier/ individual technology
- Peer and familial attitudes towards anti-social behavior

School-Based Access to Mental Health Services

- **Statistic:** 70% of youth receiving mental health services access them in school settings
- **District Context:** Schools are often the first point of contact for student mental health support

Impact on Academic and Behavioral Outcomes

- **Statistic:** Students with untreated mental health disorders are 3 times more likely to be suspended and 2 times more likely to drop out
- **District Implication:** Addressing mental health is essential for reducing suspensions and dropout rates, along with supporting the student(s) where they are

Return on Investment (ROI) of School-Based Mental Health Programs

- **Return on Investment (ROI) of School-Based Mental Health Programs**
- **Statistic:** Every \$1 invested in school-based mental health services yields \$2 to \$10 in savings
- **Benefits Include:** Improved academic achievement and reduced special education and juvenile justice costs.
- Alternative school placements can range from 38k-100k dependent upon need. Providing supports in school keeps students in their least restrictive environment and is more cost effective than placing out.
